IFIAI Capital Update

Big “I” Requests Changes to RMA’s Draft Crop Insurance Agent Compensation— In mid-October, the Big “I” took the lead in a recommendation letter to the USDA Risk Management Agency (RMA) urging specific changes to the draft managers bulletin on crop insurance agent compensation. This bulletin, which is required as part of the recently renegotiated Standard Reinsurance Agreement (SRA), will define what constitutes agent compensation and what does not for the purposes of the new, draconian commission cap that was included in the SRA.

The process of drafting this document has been an aggressive back and forth debate between the agent groups, crop insurance companies and the RMA. In the letter, the Big “I” and other agent groups have requested that the RMA continue to recognize “ordinary business practices” as they seek to define agent compensation, and that they measure all of their new compensation requirements by their practical impact on small businesses. Specifically, the agent groups have asked that RMA not expand the definition of compensation beyond what is stated in the SRA. The Big “I” has stressed that the compensation guidelines be carefully constructed to avoid creating unfair and unearned competitive advantages for companies and captive agents to the detriment of independent insurance agents.
